

299:1746 To consider and approve Fee of foreign students nominated by Indian Council of Cultural Relations in academic session 2023-24.



To get the additional weightage to the University in NAAC, timely result declaration is compulsory. During the external evaluation, the non-availability/refusal of the experts it takes too much time for declaration of results. Most of the Agricultural Universities included CSUAT, Kanpur are evaluating their Answer Booklets from their own faculties. This process was already functioning in previous years but discontinued due to not receipt of the honorarium to the faculties. To encourage the faculties, 50% honorarium will be provided to them. Expenditure of this fund will be incurred through Registrar/Hon. Vice Chancellor. The agenda was placed for consideration and approval of the Academic Council. As per ICAR 5th Deans Committee guidelines, the internal evaluation of UG & PG of Final Examination Ans. Booklets except Vety. will by other than course instructors. The Academic Council has thoroughly discussed the matter and approved the agenda. The guidelines will be circulated by Registrar.
