

## 12. RESERVATION OF SEATS FOR ADMISSION

The number of seats to be reserved for admission to the various programmes will be determined by the Academic council eyery year in advance in accordance with the provisions laid down by State Govt.

In addition the ICAR nominee qualified on the basis of test conducted by the ICAR and nominated for admission by the ICAR, will subject to eligibility, be granted admission subject to a maximum of 15% of intake capacity for U.G. programmes and 25% for Master's degree programme. Such seats shall be over and above the number of seats notified every year.

## 13. RESERVATION FOR ADMISSION TO Ph.D.

As far as possible the reservation policy of the State Government shall also be applicable for admission to Ph.D. Programme. There being only two seats in each discipline, the 1st seat shall be treated as reserved seat which may be filled by either Schedule Caste/Tribe or by the candidate belonging to OBC category on the basis of ratio of percentage of reservation for each category.

### 14. ADMISSION OF IN-SERVICE CANDIDATES

#### M.Sc. (Ag.) / Ph.D.

For human resource development process and upgradation of skills of the faculty, four additional seats in M.Sc. and one additional seat in each discipline of Ph.D. may be filled on the basis of the criteria, namely:

- (a) The in-service candidates of the University may be allowed to do M.Sc./ Ph.D. under prevailing system of University through UPCATET examination.
- (b) The in-service candidates of the University, seeking admission to the University must have completed, a minimum of 5 years service in the University to be eligible for admission and must have secured at least 50% marks at the qualifying examination.
- (c) For the purpose of admission to Ph.D. programme, only those in-service candidates will be considered eligible who hold such posts for which the basic qualification requirement (as per advertisement) is Master's degree. Other in-service candidates who hold posts for which the basic qualification is B.Sc. may also be considered for admission but they will not be entitled for admission to Ph.D. Programme.
- (d) The period of service rendered as DLC or adhoc or on fixed pay shall not be considered for the propose of calculating the length of service.
- (e) In case, the in-service candidate selected for admission is posted at out station, he/she may be transferred/attached to the main campus of the University for the prescribed duration of the programme, provided the work is not adversely affected by the arrangement.
- (f) Candidates from a particular department may be admitted to do M.Sc./Ph.D. only on the recommendation of Head of Department through Dean/Director concerned.
- (g) At the time of recommendation for admission, the committee as constituted by the Vice Chancellor shall also consider the past record of the candidate concerning his/her conduct in this University or elsewhere, If it is known that the candidate being considered for admission was involved in any act of indiscipline, the selection committee may refuse to admit him/he and in this matter the decision of Vice-Chancellor shall be final.

#### 15. REGISTERED/ENROLLED NUMBER

The Identity Number of a student shall be the University Registered enrolled number durin the course of study under the University.

#### 16. CANCELATION OF ADMISSION

In case a candidate, to whom a seat is offered, does not join within the time given, his/he admission would stand cancelled and the seat would be offered to the person next on the mei list.

As you are kindly aware that the ICAR's All India Entrance Examination for Admission (AIEEA) for the Academic Session 2021-22 have already been conducted by the National Testing Agency (NTA). Based on the result of AIEEA declared by NTA on 23.10.2021, Online counselling for admission of the candidates to the accredited AUs is scheduled to be conducted soon for which the time schedule will be notified through the AIEEA Online Counseling Brochures at <a href="https://www.icarexam.net">www.icarexam.net</a>.

Vice Chancellore

In view of the changed scenario due to COVID-19 pandemic, certain new features have been introduced in the existing format of online counselling. The Registrars/Controllers of Examination/Deans handling admissions of the accredited AUs have already been sensitized about these changes in a meeting that was held in virtual mode on 02<sup>nd</sup> November, 2021. The Minutes of the Meeting (copy attached) have already been circulated to all the participants through e-mail on 16/11/2021 for their ready reference and compliance.

The online counselling process shall require active participation and timely response of all the accredited AUs to make it a successful joint exercise. Since the admission process has already been delayed due to extraordinary circumstances created due to COVID-19 pandemic, the Admission Committee of the university may kindly be requested to work in online mode during holidays also in order to complete the online counselling process in the stipulated time frame. Needless to mention, that the timely reporting of the admission status of the candidates at the end of each round of counselling is very crucial in order to timely begin the next round.

For smooth conduct of the process, the Admission Committee may, therefore, be advised to go through the Information Bulletins of AIEEA-UG/PG and AICE-JRF/SRF (Ph.D.)-2021 available on <a href="https://www.icar.nta.nic.in">www.icar.nta.nic.in</a> and AIEEA Online Counselling Brochures of AIEEA (UG), AIEEA (PG) and AICE-JRF/SRF (Ph.D.) to be uploaded on the counselling portal (<a href="https://www.icarexam.net">www.icarexam.net</a>) to familiarise themselves about the eligibility criteria, counselling schedule, Steps for online counselling, etc. for admission of the candidates.

The list of ICAR-accredited AUs, Colleges and programmes (including private Agricultural Colleges and their programmes) etc., shall also be made available on the portal for the convenience of the Admission Committee at the universities.

The list of single points of contact at the admitting universities for admission related queries of the candidates shall also be provided on the Counseling portal (www.icarexam.net) to facilitate the admission process.

Since the registration process for admission in some of the AUs for the Academ Session 2021-22 might have already been over/about to finish by the time the Counselling process of ICAR commences, the candidates recommended by ICAR on ICA quota of seats may kindly be considered for admission.

Minutes of 5th Meeting (virtual) of the Registrars/Controllers of Examination/ Deans/ Single Point Contact of the accredited AUs and Counselling Steering Committee Members (ICAR) held on 2nd November, 2021 to sensitize them about the online counselling process for admission, eligibility requirements etc., during Academic Session 2021-22.

The 5<sup>th</sup> Meeting (virtual) of the Registrars/Controllers of Examination/ Deans/ Single Point Contact (SPC) for ICAR's admissions of the accredited AUs and Counselling Steering Committee Members (ICAR) was held on 2<sup>nd</sup> November, 2021 at 2.30 P.M. under the Chairmanship of DDG (Agril. Edn.) to sensitize them about online counselling process for admission (through ICAR's 26<sup>th</sup> AIEE), eligibility requirements etc., during Academic Session 2021-22. In addition to above mentioned representatives from accredited AUs, ADG (HRD), Counselling Steering Committee members Dr. Anil Rai ADG (ICT), Coordinator NAEAB Dr. K.P. Tripathi, COE (Agril. Edn.), Dr. Rajneesh Rana and the Director of M/s. Celeste Online Solutions Pvt. Ltd., Jaipur, the service provider for post-examination processing work of ICAR's All India Entrance Examination for Admission (AIEEA) participated in the meeting.

The ADG (HRD) welcomed the participants and briefed about the purpose of meeting. It was mentioned that seats have already been provided by all the accredited AUs under ICAR-AU system on the portal opened by ICAR for this purpose on 01-10-2021 and vetted on 25.10.2021. The AIEEA-UG, PG and AICE (JRF/SRF)-Ph.D. have successfully been conducted by NTA and scores declared on 25<sup>th</sup> October, 2021. After getting the scores from NTA, the Council is in the process of preparing the merit ranks exam-wise, subject-wise and category-wise. This will be followed by conduct of online counselling by the Council.

Thereafter, a brief presentation on overview of ICAR's AIEE 2021-22 was made by Controller of Examination highlighting the relaxations granted by the ICAR to candidates about certain accreditation requirements. It was emphasized that the eligibility qualifications for admission in different subjects/disciplines as indicated in respective Information Bulletins (IBs) available on NTA website <a href="www.icar.nta.ac.in">www.icar.nta.ac.in</a> and Counselling Brochure to be available at <a href="www.icarexam.net">www.icarexam.net</a> at the time of counselling shall be applicable for admissions during 2021-22 with some minor changes as already notified. At NDRI, for Masters degree Subject. 19.1. Food Technology/Food Science & Technology has been dropped and for Ph.D. admission, eligibility for admission in LPM has been modified.

It was reiterated that the admissions will be strictly granted only in accredited programmes of accredited college(s) of an accredited university through online counselling and the eligibility qualifications prescribed by ICAR shall prevail on 15% ICAR quota seats for UG and 25% seats each for PG and Ph.D. degree programmes. Candidates passed out from Govt. or private Agricultural Universities/Colleges not accredited by ICAR, even though constituent/affiliated to public funded/Govt. institutions, are not eligible for admission through this examination. For details ICAR Public Notice No.1(6)/2018-Exam cell-Part (IV) dated 24<sup>th</sup> June, 2021 available on NTA (www.icar.nta.ac.in) and ICAR (www.icar.org.in) website may be referred. First batch pass out/appeared/appearing (UG/PG) candidates of

Agriculture & allied sciences (during academic session 2020-21) from Non-ICAR accreditation. Govt. or Private institutions shall be eligible for admission. Some institutions have furnished (firstbatch2021.icar@gmail.com) the required details of first batch eligible students which will be available on counselling portal for the ready reference by the admitting AUs. The information related to universities like list of programmes, colleges and universities accredited by ICAR (including private agricultural colleges), course fee, tentative date of registration, hostel facility. Single Points of Contact, list of first batch pass out candidates at the AUs etc., shall also be displayed to facilitate the candidates and AUs. List of Government (outside ICAR-AU system) and Private Agricultural Universities/Colleges (accredited by ICAR) whose candidates passed out in indicated Bachelor degree programmes are eligible for appearing in AIEEA (PG)-2021 and those colleges/AUs which submitted their SSR for accreditation to ICAR on or before 17th August, 2021 whose students are eligible for counselling will also be displayed on the counselling portal.

For admission to M.V.Sc., candidate must have completed B.V.Sc. & A.H. with internship on or before the date of admission in the allotted university. The 5 years and 5½ years degree duration candidates will be counseled for admission as already delineated in the respective IB.

The candidates having 3 years' bachelor degree will not be eligible for admissions in PG and Ph.D. degree programmes except at IARI and NDRI, Karnal in few courses provided they meet the prescribed accreditation requirements. Seats for those accredited programmes that do not fit into 20 Major Subject Groups of PG and 73 Major Subjects of Ph.D., as listed in the respective Information Bulletins, have not been considered. For the subject Fish Engineering and Technology in Ph.D., no seats have been given by the AUs, hence no admission will be done.

Further, a presentation was made by Director, M/s. Celeste Online Solutions Pvt. Ltd. about the steps to be followed by the candidates as well as the officials/ SPCs involved in admission process from AUs during the process of counselling. Like last year, the candidates will not be required to physically report for admission at the admitting university during any round of counselling. Universities will be able to download list of allotted candidates roundwise and course-wise. There will be a provision of upgradation of choice by the candidates during counselling. The request for "Upgradation" will be permissible only during the first and second round of counselling. However, if the "Upgraded" University/Course has some additional requirements in respect of certain documents, then the onus shall lie on the candidate to fulfill such requirements. Rest of the counselling procedure shall be essentially similar to the last year.

The DDG (Agril. Edn.) in his concluding remarks emphasized the importance of sensitizing the AUs about the counselling and admission process as they are the equal partners in the successful completion of counselling and admission process. AUs may explore the possibility of using DigiLocker in future for the verification of academic documents of the candidates, using ICAR-NTA scores for admissions to minimize the burden on students for appearing in multiple exams and solicited the benign cooperation of AUs in successful conduct of the counselling.

After a detailed deliberation and discussion on the various aspects of online counselling and admission and the issues raised by the representatives of AUs, the following was agreed for the Academic Session 2021-22:

- The online counselling will be conducted in three rounds and Mop-up round of counselling may be conducted if the need arises.
- 2. The candidates eligible for registration will be charged Registration fee of Rs. 500/- (non-refundable) for participation in the online counselling.
- 3. Keeping in view the difficulty faced by Master degree students in completion of degree/research work due to COVID-19 pandemic or other reasons, the candidates will be provided a relaxation and the relevant documents of qualifying examination shall be accepted up to 31.12.2021. However, this relaxation is for Academic Session 2021-22 only in view of the COVID-19 pandemic and shall not be cited as precedence in future for seeking relaxation. Such candidates, however, shall be mandatorily required to upload a certificate from the Registrar of the concerned university specifically indicating that the candidate has been awarded Final OGPA/Percentage of marks at the end of final semester/year and he/she shall be completing all the requirements including thesis submission and completion of viva-voce for the award of Masters degree before 31.12.2021 along with mentioning the likely date of issuance of PDC/Degree to the candidate.
- 4. The eligible candidates who are allotted the seat (subject to document verification and payment of Seat Acceptance Fee) shall upload all relevant documents within a stipulated period on the Counselling portal for verification by the concerned universities. No documents shall be entertained from the candidate through any other mode like e-mail/fax, Whatsapp, etc.
- If the original certificates are not in English language, English translation of such certificates, duly certified by the Principal/Director or other competent authority of the institution last attended, will be required to be uploaded.
- 6. The personal details (except for the category change, if any for which portal shall be opened for two days again) and academic credentials provided by the candidates at the time of submitting the application form on NTA website will be treated as final for declaring the scores and generating the merit rank. At the time of registration for online counselling, candidates may be asked to check and give the correct name of the college/ University from which they acquired the degree.
- 7. The online verification of documents uploaded by the candidates is to be done by the allotted universities as per the details in Counselling Brochure to be uploaded at the time of counselling.
- 8. Once the uploaded documents have been found and marked "Verified" by the University, candidate will be required to pay the non-refundable Seat Acceptance Fee of Rs. 10,000/across the board, irrespective of category, on the ICAR's Counselling portal. After confirmation of receipt of Seat Acceptance Fee, the University will mark the candidate as "Provisionally Admitted".
- 9. If the candidate wants to opt for 'Upgradation', he/she may do so after the payment of Seat Acceptance Fee. Reporting of each allotted candidate (Admitted/Not Reported/Denied Admission or Not eligible) within specified time period is mandatory by the AUs for holding the subsequent round of allotment. However, the university to which he/she has been

- upgraded shall have every right to re-verify the documents of such candidates and reject the candidature/admission of ineligible candidates.
- 10. Since, every information related to admission of candidates will be available on ICAR counselling portal, the AUs shall not send any reports related to admission until and unless asked for.
- 11. The candidate, after adjustment of the Seat Acceptance Fee of Rs. 10,000/-, shall pay the balance amount of fee after physical verification with original documents at the time of reporting for registration/attending the classes in the finally allotted university or as per requirement of the admitting university. In case any forged documents have been submitted or information has been concealed by the candidate and the same comes to the notice of university authorities any stage during the studies, the university shall have the right to cancel the admission of such candidates.
- 12. In case of any discrepancy, the document, in no case, shall be sent by AUs to the Council for cross-verification/decision.
- 13. In order to avoid financial hardship being faced by the parents/candidates due to COVID-19 pandemic and related factors, full refund of fees shall be made on account of all cancellation of admissions/migration of students up to completion of Third Round of counselling i.e. END of Fee Reconciliation and Online Reporting by the Universities for this very session as a special case. The entire fee including all charges shall be refunded in totality (Zero Cancellation charges) on account of cancellation/migration. Thereafter, on cancellation/withdrawal of admissions up to 30 days after completion of Third Round of counselling, the fee collected from a student shall be refunded after deduction of Rs. 1,000/as processing fee. For any request for refund thereafter, the refund policy of the admitting university shall be applicable and no correspondence will be entertained by the Council in this regard. The refund process by the Council shall commence after the completion of admission process at the Council.
- 14. As practiced in the past, the allocation of scholarship/fellowship shall be done after the completion of counselling to those candidates who have finally been admitted in a university. In this scenario, the scholarship/fellowship will be allotted after verification of the eligibility requirements of such cases by the university authorities on the ICAR's portal. However, this will be subject to fulfilment of the other conditions for the award of Scholarships/Fellowships as given in the respective Online Counselling Brochure for the Academic Session 2021-22.
- 15. After completion of the admission process, the admitting universities shall raise the demand from the Council for transfer of consolidated fee amount equivalent to Seat Acceptance Fee (part of admission fee of the candidate) in respect of all the candidates finally admitted. The Seat Acceptance Fee shall be transferred to the concerned university account (not to individual college Dean's account) through NEFT/RTGS by the Council after the admission process is completed.
- 16. ICAR will allot the candidate to the University, whereas the allotment of the accredited College within the University allotted shall be regulated by the University itself.
- 17. For admission to M.Sc. (Hons.) Community Science programme at CCSHAU, Hisar and UG programme at CAU, Imphal only female candidates shall be eligible.
- 18. The candidates who have passed with 5 years' integrated M.Sc. degree programmes shall not be eligible to seek admission to Ph.D. degree programmes through AICE-JRF/SRF (Ph.D.) examination.

- 19. Like previous year, the candidates having passed intermediate with Agriculture should be accepted by all the AUs under the ICAR-AU system for admission in B.Sc. (Hons) Agriculture, Horticulture, Forestry and B.F.Sc. Programmes.
- 20. For admission in LPM discipline, the candidates who do not possess B.V.Sc. & A.H. degree are eligible for admission to Masters' degree programme only at SASARD, Nagaland University and CSAUA&T Kanpur.
- 21. For admission to Agricultural Extension/Extension Education/Communication programme in Ph.D. at State Vcty. Universities and Vety. Science College (s) of SAUs, only the candidates with B.V.Sc. & A.H. and M.V.Sc. (Vety. Extension) degrees shall be eligible.
- 22. The seats as verified by the AUs on the online portal shall not be changed later under any circumstances.
- 23. For admission to PwD candidates, all the AUs will follow Govt. of India directives as defined in Rights of Persons with Disabilities (RPwD) Act, 2016 and the related guidelines.
- 24. Since the seats allotted through AIEEA-2021 are essentially termed as ICAR seats, therefore, all the rules and regulations of ICAR will prevail at the time of admission to different AUs under the ICAR-AU system insofar as minimum qualifications and eligibility of students are concerned.
- 25. After the counselling is over, the vacant seats, if any, shall stand released to the AU. The same shall also be displayed on the Counselling portal for the information of candidates as well as AUs.
- 26. The contact details in respect of Single Points of Contact at each of the AUs were invited on the portal at the time of inviting ICAR quota of seats. These details shall be displayed at the time of counselling on the counselling portal to facilitate candidates so that they can contact a particular university for seeking any clarification with respect to their choice of programme(s). These SPCs shall be expected to resolve the queries/complaints of the candidates related to admission process at the university.
- 27. The AUs which expressed their willingness to use the NTA scores (their names already published in AIEEA 2021 IBs) for their admissions have to directly approach the NTA for this purpose. The DG NTA has already been intimated by the Council in this regard on 5<sup>th</sup> August, 2021.
