1. Academic Administrative Audit (AAA) and follow up action taken

University provides quality assurance through Dean/Directors/Registrar and comptroller through academic council which formulates implements and audits the academic policies for the enhancement of quality of teaching, learning, research and governance.

For quality research in the University, the planning of research experiments is initiated and discussed at Departments and finalized in the Research Advisory Committee Meetings organized in different time intervals under the Chairmanship of Hon'ble Vice Chancellor in which external experts are also invited for further improvement in respected field. Different government agencies like Veterinary Council of India (VCI) & Indian Council of Agriculture (ICAR) perform time to time audit of different academic activity. At University level Education Policy Committee is responsible for quality of education in different colleges of university.

2. Conferences, Seminars, Workshops on quality conducted

University organizes conferences/ workshops/training /expert lectures/seminars to improve the teaching and learning among students /faculties. It also helps in improvement of education and research. The Dean /DR/and Registrar are responsible for monitoring and quality control.

3. Collaborative quality initiatives with other institution(s)

University has signed 34 MoUs (Memorandum of Understandings) with government and private institutes and organization which are excellence in their field, for collaborative research and teaching. Students of the University are doing collaborative research for their thesis work with these institutions. The Dean /DR and Registrar are responsible for monitoring and quality control.
